II. Minutes

- 4. Treasurer Report (Tom Bernardo)
 - a) Current balance for checking is \$66,679.35
 - b) Federal Tax report is due. Betsy's husband declines to work on the Foundations' taxes, so Tom will do the report. Report is due on February 15.
 - c) Discussion on money spent on the World Ranger Conference. A suggestion that anything not spent on this conference should be held as seed money for the next.

- 5. Secretary Report All Conflict of Interests forms have been received with the exception of Ann Meneguzzi. Miles promised to send her another form.

1751 **B.** Active Projects

- Fire Relief Bernardo Remaining balance: \$9,618.81 + a monthly donation of \$25/month from David Garcia.
- 2. California Hospitality Association Tom got a check for \$500. Could this be a donation for the Baker/Vegas Run? The check was made out to both the CSPRA and the Ranger Foundation.
- World Ranger Congress Jeff Ohlfs \$4,059.00 left in the account. Portugal (Azores in 2022) will be the next location

One "no-show" from the rangers we sponsored. Mike congratulated Jeff for all the work he did on this project.

- 4. Killed in the line of duty project. one new ranger reported as killed in the line of duty in Peru. We contributed \$500 to the next of kin.
- 5. Baker to Vegas Run Tom Bernardo. The balance is \$4,707. This is their money not the Foundation's.
- Pink Bear program with State Parks. Tom Bernardo. Mike reported roughly \$1,200 in expenses and a profit of roughly \$3,000 will be sent off to the Breast Cancer Research Foundation. A final report will be provided later.
- 7. World Ranger Day (July 31) Where to hold the celebration? Pt. Reyes? Yosemite? Border Field? Across the Border? Santa Monica Mtns.? Old Town San Diego? Where can we get support? Jeff Ohlfs suggested that we bring this up at the PRAC Conference. Jeff will also check with Felipe on south of the border ideas. Mike will take the idea to the PRAC Conference. Jeff suggested we should ask ranger authors to donate a percentage of their profits to the Foundation.

- B. Bookkeeper for the Ranger Foundation Tom Bernardo Nothing done as yet. Tom said he isn't sure that we need a bookkeeper given the size of the Foundation. This year is a bit unusual because we brought in over \$50,000 and that triggered a more difficult tax report. Maybe we should ask ranger authors to donate a percentage of their profits to the Foundation.

That the Ranger Foundation apply to become an associate member of the IRF. There was considerable discussion based on some political considerations.

MOTION carries: 4:0 with one abstention.

Action: Miles to send in the application to the IRF.

C. Venezuela Ranger Relief – Jeff Ohlfs.

Jeff forwarded a request from Venezuela ranger Wualmort Moreno (Regional Chief) for help in acquiring some badly needed equipment for Venezuela rangers.

MOTION: by Jeff Ohlfs

That the Foundation supports equipment ranger relief. The dollar amount to be determined later by the Board based on the request we get from Venezuela.

MOTION CARRIES unanimously
