- 1. Ann Meneguzzi reported that the Best Western Hotel in San Diego has agreed to a reduced rate for the World Ranger Day on July 31.
- 2. Mike Lynch reported that Ann has been sworn in as the President of the California Alpine Club.
- 3. Tom Bernardo sent out the latest Treasurer's report to all board members by email. He also reported that the Baker to Vegas race has been postponed to 2023 so there is no activity in that fund.
