Disaster Relief – Mike Lynch
 Mike reported that he contacted Jamie to offer relief for the Yosemite fire and got
 no response. Jeff reported that the NPS solicitor's office apparently disapproved
 of the offer for ethical reasons. Apparently until there is a final decision on the
 ethics of donations to federal employees for disaster relief, they can't accept any
 relief from the Foundation.

- 4. Pink Bear Tom Bernardo
  Tom announced that he is handling all of the Pink Bear sales this year. So far sales are between \$800 \$900.

a. This year's event appeared to go well. Jeff's financial report is attached.

- 5. World Ranger Day Jeff Ohlfs
  - b. Pt. Reyes NS (NPS) has agreed to host World Ranger Day (July 31) for 2023. As of now the event will start at 10 instead of 11. The park's natural history association has agreed to bring a ranger from Georgia (country). This time space is not limiting so every ranger that wants to come will be invited. NPS will sponsor a special Jr. Ranger Day and there will be a special area to show off all the different ranger vehicles from all the different agencies. Guest speakers are yet to be decided. The event will commemorate two rangers (NPS and DPR) that died in the line of duty 50 years ago. The Fraternal Order of Police have agreed to have their "Supreme Sacrifice" medal for both rangers. Jeff suggested that the
  - Foundation support the cost of miscellaneous items (patch, FOP medal w/engraving, plates, cups, printing, banners, cake, water, roll of honor poster, etc.) that should cost just under \$400. (Apparently NPS can't pay for a number of these items.) The idea has been put forward that World Ranger Day for 2024 be held in an East Bay Regional Park.

    c. Lodging at the Alpine Club Ann Meneguzzi
  - The trustees of the Lodge have reservations about the use of the grounds due to Covid. In addition, they don't like the idea of private rentals renting out the entire facility. So, at the moment the situation doesn't appear clear.

# **Ranger Foundation Timeline**

- · October 6, 2016 CSPRA Members pass resolution at Annual Meeting in Morro Bay directing Board to establish a 501 (c)(3) charitable Ranger Foundation.
- · February 15, 2017 Ranger Foundation was established as a Nonprofit Public Benefit Corporation with the California Secretary of State's Office.
- · July 20, 2017 CSPRA Board appoints Directors for Ranger Foundation of Tom Bernardo, Mike Lynch, Ann Meneguzzi, Jeff Ohlfs, and Miles Standish.
- · November 26, 2017 Ranger Foundation Board of Directors meet for the first time and adopt Bylaws and elect officers.
- · December 19, 2017 Ranger Foundation launched a new website with CSPRA help.
- · February 1, 2018 Ranger Foundation granted charitable non-profit status with IRS and established "donation" capability.

In 2021 the RF purchased the ranger foundation domain name for our website.
